

Act XIII of 2026

laying down the list of the ministries of Hungary

[1] Pursuant to Article 17 (1) of the Fundamental Law, the ministries should be listed in an Act.

[2] In view of the above, the National Assembly adopts the following Act:

Section 1 The ministries of Hungary shall be the following:

1. Ministry of Health;
2. Ministry of Justice;
3. Ministry of Education and Children;
4. Ministry of Finance;
5. Ministry of Agriculture and Food Economy;
6. Ministry of the Interior;
7. Ministry for the Living Environment;
8. Ministry of Economy and Energy;
9. Ministry of Defence;
10. Ministry of Transport and Public Investments;
11. Ministry of Foreign Affairs;
12. Prime Minister's Office;
13. Ministry of Social and Family Affairs;
14. Ministry for Community Relations and Culture;
15. Ministry of Science and Technology;
16. Ministry for Rural and Settlement Development.

Section 2 (1) The Ministry of Health shall be established by way of a partial division of the Ministry of the Interior.

(2) The Ministry of Education and Children shall be established by way of a partial division of the Ministry of the Interior.

(3) The Ministry for the Living Environment shall be established by way of a partial division of the Ministry of Energy under Act II of 2022 laying down the list of the Ministries of Hungary.

(4) The Ministry of Social and Family Affairs shall be established by way of a partial division of the Ministry of the Interior.

(5) The Ministry for Community Relations and Culture shall be established by way of a partial division of the Ministry of Culture and Innovation under Act II of 2022 laying down the list of the ministries of Hungary.

(6) The Ministry of European Union Affairs shall cease to exist by way of a merger into the Prime Minister's Office.

(7) The Cabinet Office of the Prime Minister shall cease to exist by way of a merger into the Prime Minister's Office.

Section 3 (1) The Ministry for National Economy under Act II of 2022 laying down the list of the ministries of Hungary shall continue to operate under the name Ministry of Finance.

(2) The Ministry of Agriculture under Act II of 2022 laying down the list of the ministries of Hungary shall continue to operate under the name Ministry of Agriculture and Food Economy.

(3) The Ministry of Energy under Act II of 2022 laying down the list of the ministries of Hungary shall continue to operate under the name Ministry of Economy and Energy.

(4) The Ministry of Construction and Transport under Act II of 2022 laying down the list of the ministries of Hungary shall continue to operate under the name Ministry of Transport and Public Investments.

(5) The Ministry of Foreign Affairs and Trade under Act II of 2022 laying down the list of the ministries of Hungary shall continue to operate under the name Ministry of Foreign Affairs.

(6) The Ministry of Culture and Innovation under Act II of 2022 laying down the list of the ministries of Hungary shall continue to operate under the name Ministry of Science and Technology.

(7) The Ministry of Public Administration and Regional Development under Act II of 2022 laying down the list of the ministries of Hungary shall continue to operate under the name Ministry for Rural and Settlement Development.

Section 4 (1) Legal succession between the ministries listed in section 1 and the ministries under Act II of 2022 laying down the list of the ministries of Hungary shall be determined by a decree adopted by the Government acting within its original legislative power.

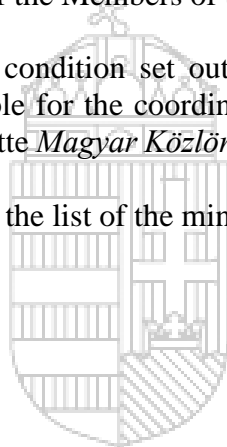
(2) The ministries referred to in section 2 (6) and (7) shall continue to operate as budgetary organs within the meaning of the Act on public finances and as government administration organs within the meaning of the Act on government administration until the date specified in the government decree referred to in paragraph (1).

(3) The minister heading the ministry referred to in section 1 12 shall exercise the powers of the heads of the ministries referred to in section 2 (6) and (7), including their powers as heads of budgetary organs. The date of termination of the ministries referred to in section 2 (6) and (7) shall be determined by the government decree referred to in paragraph (1).

Section 5 (1) This Act shall enter into force on the day of formation of the Government headed by the Prime Minister elected at the constitutive sitting of the National Assembly constituted following the 2026 general election of the Members of the National Assembly.

(2) The calendar day on which the condition set out in paragraph (1) is fulfilled shall be determined by the minister responsible for the coordination of social policy in an individual decision published in the official gazette *Magyar Közlöny* immediately after it becomes known.

Section 6 Act II of 2022 laying down the list of the ministries of Hungary shall be repealed.
